BID SPECIFICATION FOR MOWING

Lewisburg Water & Wastewater will accept sealed bids for the following work until **March 19, 2021 at 10:00 am.** in the General Managers office at 100 Water Street, Lewisburg, TN. 37091. Each bid is to be clearly marked “**Mowing Bid**”, **Opening March 19, 2021 10:00 a.m.**, placed on lower left corner of envelope. All sealed bids should be turned in before 10:00 a.m. the morning of the bid opening.

Lewisburg Water & Wastewater has certain pieces of property which require annual mowing and lawn care, Spring through Fall 2021.

Each piece of property requires a different amount of care depending on the location and weather conditions. The frequency of care to be directed by the location Supervisor. Each piece of property will be mowed with a suitable lawn mower and at a height acceptable to Lewisburg Water & Wastewater. There will be no mowing of wet grass due to rain or morning dew.

All sidewalks, structures and fences are to be trimmed or weed eat each time mowing occurs. All sidewalks, steps, drives, and all structures, either paved or concrete must be clean of grass trimmings after each mowing and trimming.

Bidders must meet all Tennessee labor laws especially regarding underage equipment operators.

Please contact Supervisors Terry Smith at 359-3345, Water Treatment Plant or Tommy Wallace at 359-2363, Wastewater Treatment Plant for a time to visit and inspect the referenced sites.

You are required to provide a list of the equipment and number of personnel you currently have which you intend to use to complete this work and a list of at least 3 commercial references. You must provide Lewisburg Water & Wastewater with a certificate of insurance showing limits of coverage for liability, Workman Compensation. Workman Compensation Insurance is not required if all work is provided by owner(s), no employees.

To ensure proper payment, the Lewisburg Water & Wastewater will require a signed receipt after each mowing to be presented to the appropriate Supervisor. We pay by invoice and do not require statements.

Lewisburg Water & Wastewater reserves the right to cancel this Contract at any time it feels the job is not being completed to its satisfaction. A contract between parties will be prepared for execution prior to commencement of work.

Bids will not be officially awarded at opening.

Terms: Invoices are paid near the 10th and 20th of each month.
